SIGNATURE OF DEVELOPMENT AUTHORITY

1. The issuance of a Development Permit in accordance with the notice of approval is subject to the condition that it do not become effective until FOURTEEN (14) days after the date the approval is publicized.
2. The Town of High Level Land Use Bylaw ~~N044-13~~ provides that any person claiming to be affected by a decision of the Development Authority may appeal to the Subdivision and Development Appeal Board by filing a written notice of appeal containing reasons, with the Secretary of the Subdivision and Development Appeal Board, Town of High Level accompanied with payment of \$100.00, payable to the Town of High Level within FOURTEEN (14) days after notice of the approval is publicized.
3. A permit issued in accordance with the notice of approval is valid for a period of TWELVE (12) months from the date of issue. If at the expiry of this period, the development has not been commenced or carried out with reasonable diligence the permit shall be null and void.

CONDITIONS OF APPROVAL

Development PermiDP21-007

1. The development shall not be altered, changed, or modified from the approved plans or specifications without written authorization from the Development Authority. (4.8.8)
2. No sign shall be illuminated unless the source of light is suitably shielded and must not negatively affect, nor pose safety hazard to, an adjacent site or road.
3. Signs shall only be approved when, in the opinion of the Development Authority the sign does not obstruct the order safe flow of vehicular and pedestrian traffic or the sight lines required under this bylaw.
4. No portion of the sign may encroach onto municipal land.
5. Wiring and conduits for electrified signs must be concealed from view.

PLEASE NOTE: ALL CONDITIONS MUST BE COMPLIED WITH
