

# TOWN OF HIGH LEVEL SECOND AMENDING 2020 FEES BYLAW BYLAW NO. 1010-20

### A BYLAW TO AMEND THE 2020 FEES BYLAW

**WHEREAS** the *Municipal Government Act* provides that a municipality may pass bylaws for municipal purposes respecting services provided by the municipality; and

**WHEREAS** the *Municipal Government Act* provides that a municipality may pass a bylaw for the establishment of fees for licences, permits, and approvals as established by Council; and

**WHEREAS** the *Freedom of Information and Protection of Privacy Act* states that a municipality must make certain information available to the public and that the Council may pass a bylaw to establish fees for the provision of the information; and

WHEREAS the Town of High Level has adopted a 2020 Fees Bylaw 998-19; and

**WHEREAS**, due to the COVID-19 pandemic, the Town of High Level has deemed it desirable to amend specific fees for the 2020 year; and

WHEREAS the 2020 Fees Bylaw do not contain a fee for land leases with the exception of airport land leases: and

WHEREAS the 2020 Fees Bylaw do not have a rate for firefighter training for external groups.

**NOW THEREFORE** the Council of the Town of High Level in the province of Alberta, duly assembled, enacts as follows:

- 1. This Bylaw may be referred to as the "Second Amending 2020 Fees Bylaw".
- 2. For the purposes of this Bylaw, the following shall have the noted definitions:
  - (a) "Council" means the Council of the Town of High Level, elected pursuant to the Local Authorities Election Act, Revised Statutes of Alberta.

9. In all other respects, the 2020 Fees Bylaw 998-19 and Amending 2020 Fees Bylaw 1006-20 are in force for the 2020 year as enacted.

10. This Bylaw shall come into force upon third and final reading.
