December 2020 the calls for service had a slight increase over last month with 191 total calls within the Town of High Level.

There were 9 reported assaults, 1 report of Aggravated Assault, Charges have been laid on 6 of those files, 1 was unfounded, 2 there was insufficient evidence to proceed with charges and 1 resolved by complainant/victim wishing no action.

There were 3 break and enter files reported, 1 remains under investigation, while the others were unfounded.

There were 3 impaired driving complaints. Additionally, December saw the start of new Provincial Sanctions targeting impaired drivers. 6 suspensions were issued under these new provisions.

There were 14 Liquor Act related incidents, charges were laid in 2 instances, and the others saw that use officer discretion and the subjects were lodged until they were sober and able to care for themselves.

There were 40 calls for mischief to property or obstruction of enjoyment of property which were all cleared using discretion.

There were 7 mental health calls, 3 were unfounded and the other 4 files the persons were dealt via the hospital.

There were 4 reports of missing persons, one of which is still open and under investigation.

There were 2 Sexual Assault files, charges have been laid on one and the other is still under investigation.

There were 8 - 911 calls, all of which were unfounded.

There were 3 reports of stolen vehicle, 2 were unfounded and one the complainant requested the matter not proceed.

There were 2 reports of uttering threats, 1 was deemed unfounded the other there was not sufficient evidence to proceed.

There were 13 allegations of failing to comply with Judicial orders which resulted in 9 charge files and 4 were dealt with by way of discretion.

Other files included assistance to other agencies, accidents, and general assistance to the public.
